We encourage all students through grade 8 to participate in the AMC 8 as part of the MAA American Mathematics Competitions. The AMC 8 must be administered by a competition manager at a public building including a school, library, or place of worship. The competition manager is usually a teacher or coach and must be an adult who is not related to any of the participants. Please send all AMC 8 answer sheets from your school or group together.

The competition manager and the principal, vice principal, headmaster, home school coordinator, or person with comparable title must sign this form and return it with the AMC 8 answer sheets.

## Certification by the Competition Manager

I certify that the following statements are true and that, if there are any exceptions, I have checked the box at the top of the second page and have listed the name(s) of the student(s). I understand that the absence of either my signature or the signature of the principal, vice principal, or person with a comparable title from this form may result in DISQUALIFICATION of all scores from our school. I understand that administering the AMC 8 before November 13, 2018 will lead to disqualification of our school's results.

1. Only students in grade 8 or below, and ages 14.5 or below participated in the competition.
2. The participants were continuously monitored during the competition, and they were separated by an empty space, if possible.
3. Participants had exactly 40 minutes of working time. (See 2018 AMC 8 Teacher's Manual for the AMC Policy on Students with Accommodation Plans.)
4. No student was permitted to proctor or score the competition.
5. No parent or legal guardian assisted in the administration of the competition. No parent or legal guardian was present in the room during the administration of the competition.
6. I collected all of the students' exam booklets following the administration of the competition. These can be returned to students after November 20, 2018.
7. After the competition, the answer sheets were kept secure and no changes were made to the answers. If the AMC 8 was given at more than one time, the exams were kept secure until all administrations were over, and all answer sheets are being returned together.
8. I have followed all the rules as stated in the 2018 AMC 8 Teacher's Manual.
